Electrical Contractors: Firms, corporations, partnerships, individual proprietorships and other types of business enterprises that provide work related to the design, installation, and maintenance of electrical systems. Company must have: a valid HIC Number (residential only), carry at least \$100,000 of general liability insurance (\$500,000 required to be in referral program), workers compensation insurance (as appropriate), and maintain the appropriate licensing/certification to work within the jurisdictions in which they conduct business.

Air Conditioning & Heating Contractors: Firms, corporations, partnerships, individual proprietorships and other types of business enterprises that provide work related to the design, installation, and maintenance of air conditioning and heat pump systems. Company must have: a valid HIC Number (residential only), carry at least \$100,000 of general liability insurance (\$500,000 required to be in referral program), workers compensation insurance (as appropriate), and maintain the appropriate licensing/certification to work within the jurisdictions in which they conduct business.

Manufacturers: Firms, corporations, partnerships, individual proprietorships and other types of manufacturing businesses that are engaged in the manufacturing of products used in the electrical or heating and air conditioning industries.

Manufacturers' Representatives: Firms, corporations, partnerships, individual proprietorships and other types of business enterprises that are engaged as representatives to sell, or solicit sales for, manufacturers as an agent in the Delaware Valley.

Wholesalers: Firms, corporations, partnerships, individual proprietorships and other types of business enterprises that are engaged as a significant part of their business in warehousing, distribution and selling of electrical and/or heating and air conditioning products to installers of these products.
